The Majlis (AC) conducted the following business:

AC-2008(VI): Reso.-1

The Chairman apprised the members of the current situation on the campus. It was informed that the campus had been peaceful during all these days. Further, meetings with the higher police officials were held who assured to extend every possible help and cooperation to the University in maintaining law and order in the Campus.

Since the reports appearing in the media were not quite fair to Jamia, it was emphasized that there was a need to present things in a proper perspective and counter the deliberate campaign of disinformation as perpetrated by the media.

The Majlis (AC) was also informed that the University had prepared and distributed 3000 pamphlets/banners to the Institutions/Universities and localities in Delhi/New Delhi for their clear perception of the facts. While sharing the views as expressed by the Chairman, the Majlis (AC) hoped to get the support and solidarity from all sections of the society. The Majlis (AC) appreciated the support received from various sections of the society.

Finally, the Chairman placed a draft letter for endorsement of the Majlis (AC) for circulation. The Majlis (AC) approved the letter (**Annexure**) and appreciated the Vice-Chancellor's act of upholding the image of the University. It was resolved to circulate the said letter in Urdu, English and Hindi.

Before concluding the meeting, the Majlis (Academic Council) reiterated its earlier decision to unequivocally condemn terror, terrorism and communal violence, and constitute a “Legal-Aid Committee” and a “Students’ Relief Committee”.

Thereafter, the Majlis (AC) observed two minute silence to pay the tribute to Prof. M.N. Meenai, a very senior retired professor of the Department of Political Science, who expired on 28.09.2008.

The meeting ended at 5.30 p.m. with a vote of thanks to the Chair.
