Before concluding the meeting, the Shaikhul Jamia (Chairman) presented the brief report about all round development of the University during the last one year such as introduction of various new academic programmes skill development courses under Community College, vocational programmes, signing of MoUs with the various universities/institutions national and international level, suggested to make paper-less environment in the university, making the campus Wi-Fi enabled, launching of submission of on-line fee payment system for students, receiving various counseling projects from private institutions/companies of the country, clearing of around 40 students in the Civil Services (Main) Examination 2014, out of them 19 students qualified in the interview of Civil Services, getting handsome pay packages by B. (Computer/Electronics) students, Awarding of Grade 'A' by National Assessment and Accreditation Council, recipient of President Award for "Research carried out in the field of Astrophysics and Cosmology and Establishment of Centre for Innovation & Entrepreneurship and its achievements etc. He also informed the members about holding of Annual Convocation-2015 and invitation of Mr. Narendra Modi, Hon'ble Prime Minister of India to grace the occasion.

Thereafter, the Vice-Chancellor thanked all the members and assured them of his continuous efforts for obtaining excellence in academic as well as research activities going on in the University.
