The Finance Committee agreed and approved the proposal of the University for write off and replacement with Government approved make and model of vehicles, subject to availability of fund.

#### ITEM NO. 6:-

#### STATUS OF UTILIZATION OF PLAN AND NON-PLAN GRANT:

The University Grants Commission has allocated a grant of Rs.206.00 crore under XIIth Plan General Development Schemes including Fellowship (Non-Net M.Phil/Ph.D) and the items which were earlier placed under Merged Schemes. A sum of Rs.150.00 crore has been released till October 2014 against the allocation. UGC also released Rs.26.00 crore as One Time Special Grant for construction of Hostel for Girls student. Additional General Development Grant of Rs.16.25 crore, being the Balance Grant, was allocated for Faculty of Dentistry.

One Time Additional Grants of Rs.20.00 crore and Rs.2.00 crore were also released for Development of Infrastructure of the University and Development of School Campus respectively. Against the One Time Special Allocation of Rs.54.20 crore a sum Rs.50.00 crore was released up to 31.10.2014.

Under the Non-Plan Grant 2014-2015, the UGC has released a sum of Rs.13103.38 lakh as on date including advance grant Rs.2996.38 lakh.

The Finance Committee noted and approved the status of Utilization of Plan and Non-Plan Grants.
