Consideration of the judgment made by the National Commission for Minority Educational Institutions for declaring Jamia Millia Islamia as Minority Institution under Article 30(1) of the Constitution.

The Vice-Chancellor informed the Majlis (AC) of the judgment of National Commission for Minority Educational Institutions declaring Jamia Millia Islamia as a minority institution under Article 30 (1) of the Constitution read with Section 2(g) of the National Commission for Minority Educational Institutions Act. The Majlis agreed with the Vice-Chancellor that after obtaining the official certified copy of the judgment, Jamia could proceed in the matter in accordance with the judgment and law, and to take up the matter with the Government (MHRD) for expeditious implementation.

The meeting was concluded at 1.45 p.m. with a vote of thanks to the Chair.
