**Thereafter, the Majlis (AC) conducted the following business:**

**AC-2013 (VI): Item-01**

**Consideration of the proposal to confer *Honoris Causa* (Doctor of Letters) upon the distinguished personalities on the occasion of Annual /Special Convocation.**

Some of the Hon'ble members of the Majlis (AC) expressed their opinions with regard to the proposal placed before the Majlis (AC). Respecting the opinions of the Hon'ble members, the Majlis (AC) considered and approved the proposal for conferring the *Honoris Causa* (Doctor of Letters) upon the following distinguished personalities on the occasion of Annual/Special Convocation in terms of Statute 29 of JMI Act, 1988:

1. His Excellency **Sheikh Nasser Sabah Al-Ahmad Al-Sabah**, Minister of Dewan Al-Amiri, Kuwait by holding a **Special Convocation**. The proposal is actually a renewal of the earlier proposal, which was approved in the Extraordinary meeting of *Majlis-i-Muntazimah* (Executive Council) held on 15.10.2012 (Reso. 01). This proposal could not be materialized in the year 2012. Now, we have received the consent from His Excellency to receive the *Honoris Causa* (Doctor of Letters) in the Special Convocation to be held on **October 30, 2013**.
2. **Mr. Najeeb Jung**, Lt. Governor, NCT of Delhi, on the occasion of the **Annual Convocation** 2013 of the University in honoring his valuable contribution of all-round development of the University made by Mr. Najeeb Jung, former Vice-Chancellor of Jamia Millia Islamia during his four-year period as *Shaikhul Jamia* (Vice-Chancellor).
3. **His Majesty Jigme Khesar Namgyel Wangchuk**, King of Bhutan, on the occasion of **Annual/Special Convocation** subject to availability of His Majesty. This proposal was earlier approved by the *Majlis-i-Muntazimah* (Executive Council) in its meeting held on 30.01.2013 (Reso. No. 03) on the recommendation of the Academic Council to confer the *Honoris Causa* (Doctor of Letters) by holding Special Convocation.

The meeting concluded at 3.45 p.m. with a vote of thanks to the Chair.
