EC-2016(III): Reso.-3

Consideration of guidelines of MHRD for enhancement of age of superannuation in respect of Non-Teaching Medical Posts in Jamia Millia Islamia.

The Majlis (EC) noted the adoption of guidelines in Jamia Millia Islamia, as conveyed by the MHRD vide letter No. 65-7/2016-Desk(U) dated 29.07.2016 issued by the Ministry of Health & Family Welfare, Gol vide Order No. A.12034/1/2014-CHS-V dated 31.05.2016, for enhancement of age of superannuation in respect of Non-teaching Medical Posts [specialists of Non-teaching and Public Health subcadres of Central Health Service (CHS) and General Duty Medical Officers of CHS] in Central Universities to 65 years subject to the conditions that these posts are similarly situated as the counterparts in CHS in terms of qualifications and the nature of functions (Annex-I).

Consideration of the proposal for fixing the date of holding the Annual Convocation-2016.

The Majlis (EC) considered the date of holding the Annual Convocation-2016 of the University for the purpose of conferring of Degrees/Diplomas and other distinctions of the University.

The Majlis (EC), after detailed deliberations, decided to hold the Annual Convocation-2016 in the last week of November subject to availability of Chief Guest to grace the occasion with the authorization to the Vice-Chancellor to invite any one of the following eminent personalities:

 i) His Excellency Dr. Mohammad Hamid Ansari, Vice President of India; or

ii) Prof. Amartya Kumar Sen, Nobel laureate & Bharat Ratna awardee.

The Vice-Chancellor is also authorized to nominate any other eminent personality, if both the above are not available.

EC-2016(III): Reso.-6

Consideration of an appeal dated 31.05.2016 of Mr. S.K. Verma, Assistant Professor, presently posted in the Department of Hindi, against imposition upon him the penalty of 'withholding of two increments with cumulative effect' imposed by the Executive Council held on 07.05.2015, stayed by the Executive Council held on 27.11.2015 and restored by the Executive Council held on 15.03.2016.

The Majlis (EC) was apprised that Executive Council in its meeting held on 07.05.2015, after going through the Enquiry Report, charges framed against Mr. S. K. Verma, his representations and other relevant records, reviewed the penalty of "removal from services" and resolved to impose "withholding of two increments with cumulative effect". It was further resolved that his conduct will be under scrutiny for next five years and will be reported back to the Executive Council.

The Majlis (EC) also noted that Mr. S.K. Verma submitted an appeal dated 27.07.2015 against the said decision/penalty which was placed before the Executive Council held on 27.11.2015 and it was resolved to:

- Stay operation of Order No. Gen. 4-111(RO)/(Estt)/2015 dated 08.06.2015 regarding imposition of penalty of 'withholding of two increments with cumulative effect" against Mr. S. K. Verma till further orders.
- 2) Provide Mr. S. K. Verma, a copy of Inquiry Report and an opportunity to submit any representation against findings of the Inquiry for consideration of the Competent Authority.

Accordingly, Mr. S.K. Verma was provided a copy of inquiry report vide office order dated 28.01.2016 and given an opportunity to submit representation against findings of the inquiry. Mr. Verma submitted his representation dated 19.02.2016 against findings of the inquiry which was placed along with his earlier representation dated 09.01.2015 before the Executive Council held on 15.03.2016. The Executive Council, after perusal of the said representation of Mr. Verma and findings of the inquiry, resolved to uphold earlier decisions of its meeting held on 07.05.2015. Consequently the penalty of 'withhold two increments with cumulative effect' and scrutiny of his conduct during the next five years was imposed upon him vide order dated 02.05.2016.

The Majlis (EC) after due consideration of the present appeal dated 31.05.2016 against imposition of the said penalty and all the facts, Inquiry Report, decisions of the Executive Council dated 07.05.2015, 27.11.2015 and 15.03.2016 found that, contrary to submissions of Mr. Verma, repeated opportunities had infact been provided to him to cross – examine complainant's witnesses and examine his own witnesses. Statements of witnesses and relevant



documents were also supplied to him. Since the case was of continuation of enquiry, there was no material irregularity in constitution of the Committee. The analysis of evidence and findings of the Committee were acceptable. It was resolved to reaffirm its earlier decision of imposition of penalty of withholding of two increments with cumulative effect and scrutiny of conduct for five years.
